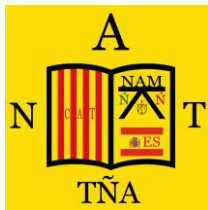

# Report about the Situation of Micronational Simulationism

---

## ¿What is simulationism?

We understand simulationism as the action, by a micronation, of inventing some of the basic aspects about its micronation in addition to carrying out clearly false or illicit actions. These are the following:

- The country's history,
- The country's citizens (amount and personal information),
- Inventions about wars:
  - Invention of the number of murdered,
  - Invention about the sides and the history of a war,
  - Etc.
- Invention of terrorist acts or problems with macronations that may not be probable.
- Other similar actions of proved falsehood that micronations carried out.

## Simulationism as an international crime.

The serious nations and micronations look for real and true relationships. Meeting groups of people disposed to play with those who are really real can destabilize a serious micronation or group of micronations. For this reason, it is considered illicit and in many places a crime the action of simulationism.

## Cases of simulationism investigated for this report.

For this report, an extraordinary commission for international investigation of the government of Troncopaña has collaborated with other countries to determine one single case of simulationism that, lately, has been stalking lots of micronations from the immediate surroundings of Troncopaña; this is the case of the Kingdom of Catan.

## EVIDENCIES OF SIMULATIONISM –KINGDOM OF CATAN–

- The great amount of money that their government pretends to invest in national matters and in international business have not a clear real origin. For that reason, every information given about these projects is false and it is a principle of simulationism. The affirmations that Mrs. Barnet and the government of Catan do and have done mean a clear aspiration to micronational superiority before other micronations, through lies and falsehoods.

- The false stories created by Catan that indicate conflictivity with the United Kingdom are false, too, because it does not exist any information in newspapers or other media about these conflicts.

So we consider them false and, again, a trial of attracting attention and publicizing themselves. Moreover, there is no evidence about any investigation by the government of Catan about that, so its more than possible falsehood is evidenced.

- Jake Finch, supposed prime minister of Catan before Abigail Barnet. He is accused by the state of Catan of paedophilia. However, we have found no evidence about if those accusations are true or real. Moreover, we have not found any personal information about Jake Finch (neither Twitter™ account nor Facebook™ account). It has just been found a photography of the king of Catan with someone that (according to him) is Jake Finch, however, there are no more evidences about that, so we cannot know 100% sure if this person is really Jake Finch.

So we suppose that affirmations made are false, too. Therefore, this fact incurs in a crime of calumnies and, in the very improbable case it was true, it would incur in a crime of defamation; both considered very serious crimes.

If they were false, that would mean that the government of Catan is able to degrade publically innocent people for making itself some publicity, which is not only unacceptable but intolerable, too.

## CONCLUSIONS

The government of the state considers, after this investigation, that the Kingdom of Catan is a fully simulationism. It is considered that the level of simulationism Catan has is Very Critical, this is, that they endanger national security and rights of individual persons of their own micronation and the rest of the world; and, also, that they endanger the integrity, security and reputation of the micronations in their surroundings.

The levels of simulationism will be the followings:

- **Low:** It is a simulationism but it does not endanger any micronation or macronation nor the individual and collective rights of internal or external persons to its micronation. This level is not considered illicit nor a national crime.
- **Moderate:** It is a simulationism and can affect other nations in the area close to theirs but not in a critical way. This level is not considered licit but it will not be a national crime.
- **Critical:** That affects other micronations or macronations and that endangers its identity in addition to its national security. At no moment this affects to the human rights of anybody in a serious way. This level is considered illicit and a national crime, however it will not be a priority in Troncopaña.
- **Very Critical:** That affects or can get to affect seriously micronations and/or macronations in its surroundings and the rest of the world in general, affecting their national reality, integrity, balance, security and reputation. Moreover, it can endanger or get to endanger individual and/or collective rights of people inside and outside of its microstate. This will be considered national priority and will be completely illicit and considered a crime nationally and internationally or intermicronationally. These nations will not be able to maintain any kind of diplomatic relationships with Troncopaña and it will be tried to make them disappear to avoid damages in the global framework of micronationalism.

**(These levels of simulationism will be applied as regulations in Troncopaña by the government of the state, because of this report)**

We consider, then, that the Kingdom of Catan is a microstate without right to existence and, for being a direct problem for Troncopaña and for other states of the world, it must disappear. Therefore, Troncopaña will stop recognising Catan as a licit and real micronation and will cut any relations with them.

As secondary measure, there will be blocked in Twitter™, the social network more used by them and where all problems occur, all those accounts relative to this state's government.
